### GETTING STARTED

Starting a memorial fund is quick and easy.

2. Memorial gifts are prompted by messages in obituaries and/or programs, “The family suggest memorials to Citizens Foundation, 100 E. College Drive Colby, KS 67701.”
3. Determine how you would like the memorial funds to be used using the list to the right.
4. The Citizens Foundation recognizes memorial funds in a loved one’s name on our memorial board when the total reaches at least \$500.

## Designation Options

When you or your family creates a memorial fund for your loved one, you have the opportunity to designate what the funds will be used for.

You can specify if you would like your funds to be designated for:

- Citizens Medical Center
  - Prairie Senior
- Family Center for Health Care
  - Particular Department
    - Particular Item
- Patient Resource Fund
- Greatest Area of Need

You can also call and speak with the Foundation Director if you have a specific project in mind. We are happy to work with you and the family to find the best use of the memorial funds.

*Please Note: The total amount of the memorial funds do not need to equal the amount of an item. The funds can be designated for a particular item and will be used when adequate funds have been donated through our memorial program.*
